Master Transloader Insurance Requirements Checklist

A CERTIFICATE OF INSURANCE SHALL NOT CONTAIN FALSE OR MISLEADING INFORMATION. THE CERTIFICATE MUST ONLY CONTAIN STATEMENTS THAT ACCURATELY REFLECT THE POLICY OR ENDORSEMENT EXTENSIONS FROM YOUR POLICIES.

COMMERCIAL GENERAL LIABILITY COVERAGE

Requirements on Certificate of Insurance:

- Per Occurrence Box Checked
- Each Occurrence & Aggregate - \$5,000,000

Required Endorsements: Each in favor of Nucor*:

- Additional Insured Endorsement – CG 20 10 07 04 and CG 20 37 07 04 (or comparable endorsements upon Nucor approval)
 - Primary and Non-Contributory Endorsement
 - Waiver of Subrogation Endorsement
 - Cancellation Endorsement

AUTO LIABILITY COVERAGE

Requirements on Certificate of Insurance:

- Covered vehicles boxes must be: (1) Owned, Hired, Non-Owned or (2) Any
- Combined Single Limit - \$5,000,000 shown as limit

Required Endorsements: Each in favor of Nucor*:

- Additional/Designated Insured Endorsement – CA 20 48 02 99 (or comparable endorsements upon Nucor approval)
 - Waiver of Subrogation Endorsement
 - Cancellation Endorsement

WORKERS' COMPENSATION / EMPLOYER'S LIABILITY COVERAGE

Requirements on Certificate of Insurance:

- WC - Statutory Limit box checked
- EL - \$5,000,000 shown as limit

Required Endorsements: Each in favor of Nucor*:

- Waiver of Subrogation Endorsement
 - Cancellation Endorsement

PROPERTY/WAREHOUSE LEGAL LIABILITY COVERAGE

Requirements on Certificate of Insurance:

- Aggregate Limit - \$5,000,000 shown as limit

Required Endorsements: Each in favor of Nucor*:

- Loss Payee Endorsement
 - Waiver of Subrogation Endorsement
 - Cancellation Endorsement
